CENTERVILLE - Today President George Bush delivered a speech defending his decision to go to war in Iraq. In his speech, President Bush quoted from the Quran, chapter 5, verse 32.

Last week Prince Charles visited President Bush. According to the British online edition of the Telegraph, one of the stated purposes of the trip was for "Prince Charles to plead Islam's cause to Bush."

Truth For Muslims will comment soon about both of these developments: the use of the Quran by President Bush and the promotion of Islam by Prince Charles.

The long term plans for Muslims to attack America on every front:
including hate-crimes legislation to force non-Muslims into
submission

Dr. Anis Shorrosh, an Arab Christian who immigrated to the United States from Jerusalem in 1967, writes about a 20 year plan Muslim leaders have to promote Islam in America. Sharrosh states his first point bluntly by saying that Muslims want to "terminate America's freedom of speech by replacing it with hate crime bills state-wide and nation-wide."

According to a September 4, 2005 report published by The Indianapolis Star, nearly 40,000 Muslims attended the annual convention of the Islamic Society of North America near Chicago,

IL. One of the seminars included discussions about "how to apply pressure on politicians who smear the faith, the benefits of corporate boycotts and what constitutes legal grounds for defamation suits."

One of the speakers at the convention, Arsalan T. Iftikhar, said that Muslims should "defend the image and reputation of the community and Islam in general. I am here to teach you how the American Muslim community can legally empower itself to protect itself in the American courts."

Forced Labor by Saudi couple in Denver

According to a June 9, 2005 press release on United States Department of Justice web site, a Saudi Muslim couple were indicted in Denver for holding an Indonesian woman captive as their slave. The couple created "a climate of fear and intimidation. . . .which was intended to cause the victim to believe that had she not performed the services, including cooking, cleaning, child care and other domestic labor, that she would suffer serious harm. . . .The defendants allegedly confiscated and concealed the victim's Indonesian passport and United States visa, and harbored her for the purpose of obtaining domestic services for little or no wages or pay."

James Casey, FBI Acting Special Agent in Charge, stated, "In a free country such as ours, during these modern times, it is unconscionable that individuals would take such tremendous advantage of another. In this case the victim came into the United States legally, only to have her freedom taken away. That conduct is criminal, and there can and will be consequences."

Jeffrey Copp, special agent in charge of the Denver Office of Investigations for U.S. Immigration and Customs Enforcement (ICE), said "Few crimes are more repugnant to our society that enslaving other human beings," said "It's hard for many people to believe that forced labor still exists in this country."

According to a report in the New York Sun on June 16 by Daniel Pipes, the husband is chief executive of Al-Basheer Publications and Translations, a bookstore specializing in titles about Islam.

Pipes also reports that the problem of slavery among Saudis in America is not uncommon, citing examples from cases in Miami, Washington, Houston, Boston, and Orlando over the last two decades.

Pipes asks, "Why is this problem so acute for affluent Saudis? . . . Although slavery was abolished in the kingdom in 1962, the practice still flourishes there. Ranking Saudi religious authorities endorse slavery; for example, Sheikh Saleh Al-Fawzan insisted recently that 'Slavery is a part of Islam' and whoever wants it abolished is 'an infidel.'"

Terrorist enemies learned from Hurricanes Katrina and Rita:
U.S. is vulnerable to disruptions in the energy supply

According to Daveed Gartenstein-Ross in an article published October 3, 2005 by the *Weekly Standard*, "THERE CAN BE NO DOUBT that our terrorist enemies keenly watched both Hurricane Katrina and Hurricane Rita. One clear lesson they will seize on is the inadequacy of the governmental response to Katrina, which suggests that we're unprepared to handle the effects of a major terrorist attack. Another clear lesson is the U.S. economy's vulnerability to high energy prices."

He explains that oil installations in Saudi Arabia are vulnerable to terrorist attacks and that such attacks can have a major impact on world oil supply. . . .

Newsweek quotes former CIA agent Robert Baer, who describes the effect that a coordinated attack on Saudi Arabia's oil installations would have on world oil prices: "A few ruptured pipes could be repaired quickly," says Baer, "but a concerted attack at several points could bring on the kind of nightmare scenario that U.S. officials have been dreading since the Reagan years,

pushing oil prices up from their current prices in the range of \$60 to \$70 a barrel to well over \$100 for weeks or even months."

According to Gartenstein-Ross,

"the Washington, D.C.-based SITE Institute has reported that a mid-August post on a password-protected internet forum affiliated with al Qaeda asserted that attacks on Saudi oil pipelines would have a greater effect on the United States than a chemical weapons attack by creating 'a big economic disaster for the American public.' The post's author noted that bin Laden had referred to this as an effective method of damaging the American economy, and concluded with a call to arms: 'Start it. Start it, al-Qaeda men.'

The influence of radical Wahhabi Islamic
teachings in our prison system

For many years the growth of Islam in American prisons has been well known. In the September issue of Truth Messenger, the newsletter of Truth For Muslims, a report titled *U.S. Prisons Fertile Ground for Islamic Growth* explained how a militant Islamic group is based at New Folsom State Prison in California.

Chuck Colson, founder of Prison Fellowship, commented about the Islamic influence in our nation's prisons on October 18, 2005. Colson ends his commentary by saying, "We need to counter falsehood with the truth by bringing the Gospel to our prisons, as Prison Fellowship does, because the best way to keep a man from acting on his resentment is to free him from it—something that the preachers of hate know nothing about it."

Daveed Gartenstein-Ross reports in the September 26, 2005 edition of the Weekly Standard that in 2004 law-enforcement agents raided the offices of an Islamic foundation headquartered in Oregon. On the computers which were seized in the raid, records were discovered which showed where the group had sent its literature. Among the 15,000 names in the database records, a significant number were prisoners. "Prisoner Number" and "Release Date" were two of the fields in the database records. The Islamic foundation also mailed bulk quantities of literature to Muslim prison chaplains who then distributed the literature to the prisoners.

The literature taught and promoted violent jihad against "disbelievers, communists and the aggressors from Jewish-Christian nations".

Chuck Colson is right. America's prisoners need to be set free from hatred and resentment. This can happen by replacing the preaching of Islam with preaching the gospel of Jesus Christ in our prisons.

Woman from Afghanistan has become a Christian
and is living in fear for her life - in America!

A woman from Afghanistan who has come to faith in Christ is keeping her faith a secret from her family members. Although the men in the family have seen the positive change in her life, she is fearful of them. She is afraid her male relatives will become violent against her if they find out she no longer believes in Mohammed as a prophet and that she is now a Christian.

Truth for Muslims receives information about former Muslims from across the country. Like the woman mentioned above, there are usually reports of fear of violence from Muslim relatives against the former Muslims. Racist ideology, fundamentalist Islam, and Jihad

The white racist group called Aryan Nation hates Jews and wants to see them eliminated. Their hatred of Jews is motivating them to link their ideology with some of the goals of the Islamic fundamentalists.

On March 29, 2005 CNN reported an interview with the leader of the Aryan Nation, August Kreis. "You say they're terrorists," says Kreis about the 9/11 attackers, "I say they're freedom fighters. And I want to instill the same jihadic feeling in our peoples' heart, in the Aryan race, that they have for their father, who they call Allah."

What message would Kreis like to deliver to Osama Bin Laden? "The message is, the cells are out here and they are already in place," Kreis said. "They might not be cells of Islamic people, but they are here and they are ready to fight."

According to the CNN report, the FBI has not been able to verify any links between American white supremacists and groups like al Qaeda.

Now the Aryan Nation is praising the November 9 bombings in Amman, Jordan. On their internet web site, a statement says, "All U.S., Jew and allied interests around the globe are considered legitimate targets as far as al-Qaeda, the protectors of True Islam, is concerned. . . . ALL foreign held and owned interests in Islamic lands can and should be targeted along with U.S., Jewish and allied interests around the world! We of Aryan Nations believe

that these individuals that are giving their lives toward ridding their lands of Jewish interest are completely justified."

The dangers of the Islamic threat to Europe's future is as dangerous as the Nazi threat was to Europe 70 years ago

"The threat of the radical Islamists taking over Europe is every bit as great to the United States as was the threat of the Nazis taking over Europe in the 1940s." So states Tony Blankley in an opening sentence of his September 12, 2005 commentary published in Washington Times.

"We cannot afford to lose Europe," says Blankley. "We cannot afford to see Europe transformed into a launching pad for Islamist jihad."

Blankley further states,

Muslim sections of Paris, Rotterdam and other European cities already are labeled "no-go zones" for ethnic Europeans, including armed policemen.

As the Muslim populations -- and their level of cultural and religious assertiveness -- expand, European geography will be "reclaimed" for Islam. Europe will become pockmarked with "little Fallujahs" that effectively will be impenetrable by anything much short of a U.S. Marine division.

And now for two weeks, Muslims have be rioting and setting fires in France. We are witnessing the explosion of the ticking time bomb in Europe right now on the news. It might subside for a while, but it will pop up again if Western governments don't grab the bull by the horns and aggressively confront the Islamic challenge.
